I am acquainted with ISAF RRS Part 1 Fundamental Rule 4: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."

Competitors give absolute right and permission to the Organizing Authority, Rolex S.A., the Farr 40 Management Group and the Farr 40 Class Association for any photography and video footage taken of persons and boats during the event to be published in any media whatsoever, including but not limited to TV advertisements, for either editorial or advertising purposes or to be used in press information.

I further expressly agree that the foregoing release and waiver is intended to be as broad and inclusive as is permitted by law and that if any portion, clause or subclause hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full and legal effect.
